Foundation Awards Funds for Innovation



Mrs. Asher's students received ukuleles for their music classroom through a Foundation mini-grant. The ukuleles will be used by these students from Mr. Thorson's 3rd grade class as well as the other students at Jefferson Elementary. Grants for ukuleles were also awarded to Mrs. Cruser at Kennedy Elementary and Mrs. Willoughby at Buchanan Elementary.

The Foundation awarded seven mini-grants through its Fall Mini-Grant Program, bringing the total number of grants awarded to classroom teachers to 194 over the 20 year history of the Foundation. The new grants range from \$160 to \$1,200 and provide teachers with funding to enhance the classroom experience.

"Sometimes the amount of our grants seem small, but the impact on the students is significant," according to Jennifer Stalley, Executive Director of the Foundation. "The benefit to these teachers and their students is there and the Foundation is proud to be able to make these grants happen through the generosity of our donors."

Fall Mini-Grant Awards

Ukuleles for the Elementary Classroom

Julie Willoughby (Buchanan Elementary), Emily Asher (Jefferson Elementary) and Melody Cruser (Kennedy Elementary)

This funding provides access to ukuleles in the elementary school classrooms to introduce string instrument techniques to support comprehension of the state music standards. The funding will also help utilize existing music technology units in the Quaver program in the classrooms.

Only One You

Megan Deal and Jen Costa (Kennedy Elementary)

This funding helps with a project to nurture students' sense of self and uniqueness to encourage students to not always follow the crowd. The funding will help the instructors teach lessons from the book "Only One You" which will culminate in a playground project on the school grounds.

Everyone's Voice is Heard with QBall

Jackie Richey (Jefferson Elementary)

This funding funds a QBall for the classroom. The QBall is a throwable, wireless microphone for classrooms to help encourage student participation in class. The QBall also adds movement to the classroom to get the students moving while learning.

Whisper Phones

Amber Stout (Jefferson Elementary)

This funding funds a classroom whisper phone. A whisper phone enables a child to intentionally listen and hear sounds coming directly from his or her own voice. This focus allows students to develop phonemic awareness. Directly hearing the sounds improves the ability to recognize and distinguish the sound structure of language.

Power Chef Culinary Program

Stephanie Todd (Georgia Morse Middle School)

This funding supplements funding from South Dakota State University to implement the Power Chef Culinary Program in the classroom. This eight week program teaches students the importance of food safety, preparation, and nutrition. The program teaches the basics of cooking, ending with the preparation of a full meal by the end of the program.
