The Foundation recognized 25 T.F. Riggs seniors as Scholars of Excellence and the 16 educators they nominated as Educators of Excellence at the 2019 Evening of Excellence in May. The Evening of Excellence celebrated graduating seniors with at least a 3.75 grade point average. Additionally, the evening recognized the educators who made a difference in the educator being named the 2019 BankWest Educator of Excellence.

Kelly Brandt, T.F. Riggs High School physics teacher, received the 2019 BankWest Educator of Excellence award and a \$1,500 grant from BankWest. Brandt was nominated by members of the Class of 2019 who noted his enthusiasm for teaching and the work he does to prepare students for careers in engineering, physics, science and math. Brandt's commitment to making the effort to make complex topics understandable and his genuine interest in his students made Brandt standout among the other nominees for the Class of 2019.

According to Janelle Toman, Foundation Vice President and emcee for the event, "Pierre is so fortunate to have outstanding teachers at every level of our system. The impact that a teacher can make on a student or a class cannot be overstated." Toman added, "It is a very difficult task to have to choose one educator to recognize each year, but it is wonderful to have so many nominees – made directly from the students – to choose between."

The same can be said of the 25 students recognized at the event. While the Class of 2019 is one of the smallest to graduate from T.F. Riggs in decades, the percentage of the class recognized as Scholars of Excellence is among the highest in the Evening of Excellence history. "The Class of 2019 may be small in numbers, but it is as impressive as any class the Foundation has recognized with the Evening of Excellence or our scholarships for students in the 20 plus years of the Foundation," according to Jennifer Stalley, Foundation Executive Director. "This is an impressive group of students and the Foundation is excited to see all the things they will achieve with their Pierre education," said Stalley.

In addition to recognizing the Scholars of Excellence and the Educator or Excellence Nominees, the Foundation also awarded its six scholarships to graduating students. These scholarships ranged in amounts from \$1,000 to \$4,000. (See pages 4-5 for the 2019 Foundation scholarship winners.) ۲

# **From the President**

When the Pierre Educational Foundation was created in 1995, its goal was to promote the educational development of students, staff,

and graduates of the Pierre School District through delivery of quality educational opportunities and resources.

As a 501(c)(3) non-profit, community-based organization, the Pierre Educational Foundation's mission is to inspire academic excellence. A most visible example of that commitment is the annual Evening of Excellence held each year in early May, when the foundation honors and recognizes outstanding senior students and faculty members from Riggs High School. We also support scholarships for **Riggs High School graduates, which** are awarded through the generosity of families and donors with close connections to the Pierre area.

As we all consider ways to further the educational development of Pierre School District students and graduates, we also know that state and education agencies are called on to meet the growing workforce demands across South Dakota and this region.

Over the last several years, agencies representing postsecondary education, workforce development, and labor have been talking about statewide attainment goals. One that the state of South Dakota took particular interest in was a goal that 65 percent of South Dakota citizens, ages 25 to 34, hold some type of postsecondary credential by 2025. This goal addressed a wide range of educational attainment from technical certificates and apprenticeships to associate, bachelor, and graduate degrees.

The 65 percent goal was based on projections from the Center on Education and the Workforce that roughly 65 percent of all jobs in South Dakota would require some level of postsecondary education by 2020. This has been an important starting point for discussions among higher education providers, policymakers, community advocates, and business leaders.

I think we can all agree there is a need to educate more South Dakotans to higher levels for a knowledge- and service-based economy. The 65 percent goal is ambitious, and it will likely take us longer than 2025 to reach it. The Pierre Educational Foundation stands ready to partner in the educational development of our community's most precious resource: our children.

## James and Gertrude Mueller Scholarship

The James and Gertrude Mueller Scholarship is offered to a T.F. Riggs High School graduating senior planning to enroll in an accredited college or university who intends to pursue a career in the medical field. This scholarship is in the amount of \$3,500. Jordan Thompson received the 2019 Mueller Scholarship. Thompson intends to pursue a career in medicine, possibly genetic research.

Thompson maintained a 4.0 grade point average while being active in a number of extracurricular

activities, including being a member of the National Honor Society, the Spanish Club, and Future Business Leaders of America. Thompson was the track and volleyball manager and attended Girls State and YBA. She served as a page for the state legislature and volunteered at the Discovery Center and the Gov to Gov store during high school.

Thompson's passion for pursuing a career in healthcare is driven by her own medical challenges.

## Schliessmann Family Scholarship

The Schliessmann Scholarship is offered to a T.F. Riggs High School graduating senior planning to enroll in an accredited college or university to pursue a career in a science, technology, engineering or mathematics. While academic success is considered, the scholarship's purpose is to support a student with a high likelihood of success in a field. This scholarship is in the amount of \$1,000 and is renewable for up to 3 years, for a total award of \$4,000. Jordan Thompson received the 2019 Schliessmann Scholarship. Thompson has a rare health disease. She overcame complications from the disease to excel in her academic career and motivate herself to pursue a career in medicine, possibly genetic research.

The Charles "Lindy" and Shirley Feeney Scholarship is offered to a T.F. Riggs High School graduating senior who is in need of financial assistance to further their education beyond high school. The purpose of this scholarship is to assist a dedicated track athlete in his/her higher education costs. This student must have participated in track & field for at least three years, and must be accepted to an accredited college, university or technical school. This scholarship is \$1,000.

Frank Becker received the 2019 Feeney Scholarship. Becker will attend Black Hills State University in the Fall to pursue a career in healthcare. Becker was a member of the varsity track team. He worked hard to overcome injuries in his track career and to continue to compete at the highest level. While his accomplishments on the track were impressive, his personal story and plans for the future are especially compelling.

Becker came to TF Riggs via an orphanage in Uganda, shortly before beginning his high school career. He worked hard in learning a new culture, a new language and settling in a new home. His strong work ethic, kind spirit and commitment to his community made him an excellent member of the track team and an outstanding member of the Class of 2019.

She volunteered for MOPS and the Discovery Center during high school, helping children learn in a variety of venues. She is also an accomplished photographer.
